Norway Document Checklist - Tourist

Documents	Description	Format
Original Passport	Original current passport and all previous passports. Passport must be valid at least 3 months beyond intended travel, issued within the previous 10 years, and containing at least two blank pages	
Copy of Passport Pages	Copies of the biodata page and all used pages in your passport.	
Photograph	Applicant's passport photo (white background) not older than six months (35-40MM).	
Application form	Visa form filled and saved from: https://www.udi.no/en/	
Flight tickets	Confirmed booking (travel itinerary) of roundtrip air ticket, with fixed travel dates of maximum 90 days and correct number of entries, see the regulations of entries. Do not buy the ticket until visa has been granted. Note: The visa will be issued according to the dates on the flight bookings	
Hotel Tickets	Confirmation of accommodation in Norway and other Schengen countries to be visited	
Cover Letter	Signed cover letter from the online Application Portal Norway received by e-mail. It can also be retrieved online from the Application Portal.	Cover Letter Template
Appointment slip	This needs be carried on the day of appointment	
Travel Insurance	<ul style="list-style-type: none"> At least € 30.000 of medical costs are reimbursed, including hospital care, emergency treatment and repatriation Insurance policy has been taken out in applicant's name Insurance is valid throughout the Schengen area and for the duration of travel 	
Bank statement	Copy of bank account(s) covering the last 6 months	
Power Of Attorney	Letter granting Power of Attorney. (Optional for applicants who want another person to represent them in the case. Separate form for Power of Attorney can be found here .)	
If traveling as a packaged tour group	<ul style="list-style-type: none"> Certificate of the travel agency confirming the booking and itinerary of an organized trip or any other appropriate document indicating the envisaged travel plans. If travelling independently: a detailed plan/schedule Confirmation of payment from the travel agent when going on cruise or any other package tour. 	
If Employed	<ul style="list-style-type: none"> Payslips for the last three months Employment contract Employers statement on approval for holidays (NOC) 	
If self - employed	<ul style="list-style-type: none"> Certificate of registration of the company 	
If student	<ul style="list-style-type: none"> NOC from the school
